Who We Are

Family Law Information Centres offer assistance for Albertans to make family law applications, provide information on Child Support Guidelines and other areas of family law.

What we do

- We can give you information about family law.
- We can tell you which court forms to use to make a family law application.
- We can tell you the steps to take in making a family law application.
- We can act as a commissioner for oaths for court documents.
- We can refer you to legal and other resources in the community.

What we cannot do

- We cannot give you legal advice on your particular circumstances. You must see a lawyer for that.
- We cannot help you choose if there is more than one way to solve your legal problem (that's legal advice).
- We cannot help you make complicated legal applications.
- We cannot fill in the court forms for you.

Calculating Child Support

If you are making a court application dealing with child support, or if you simply want to know what amounts of child support should be paid, we can help you with your calculations.

Bring us:

- proof of your income (pay stubs or tax return)
- proof of other parent's income (if you have it)
- a list of all of the special expenses that may be claimed (e.g. child care, medical costs)

We will use this information to prepare a printout showing the amount of child support payable under the Child Support Guidelines.

*If you are making a court application, specific documents may be needed before we can calculate child support for you. Please phone us for information on what documents we need.

Court Forms and Instructions

At the Family Law Information Centre, we have court forms, instructions and court procedure booklets that can tell you how to make many kinds of family law applications in court.

We have Forms and Instructions to help you:

- make an application under the *Family Law Act* or the *Divorce Act*
- apply for or change child support or spousal support in the Court of Queen's Bench or Provincial Court



- apply for or change child support or spousal support if the other party lives outside Alberta
- apply for or change parenting orders (or custody and access orders)
- apply for a restraining or protection order
